MINUTES OF THE ELECTORAL BOARD

The Greensville County Electoral Board met on Friday, February 22, 2019 for the purpose of electing officers for the year. It was agreed that the slate of officers would be as follows: Nathaniel Jones, Sr. as Chairman, Linda B. Richardson as Vice-Chairman, and Jesse B. Harrell as Secretary. Mr. Harrell completed the Electoral Board Information Form to be provided to State Board of Elections.

Mrs. Conwell advised on January 8, 2019 letters and notices were sent to the Officers of Election to serve the term beginning March 1, 2019 until February 28, 2020. Those present reviewed the notices that had returned.

It was discussed that code section 24.2-110 indicates a day in May or June, the Electoral Board would meet to appoint the General Registrar for a term of four years, beginning July 1, 2019 and ending June 30, 2023. It was a unanimous decision of the Electoral Board that Mrs. Conwell continue to serve in the capacity as General Registrar. Mrs. Conwell was very grateful. Mr. Harrell completed the General Registrar Certification of Appointment form to be provided to State Board of Elections.

At this time, it was not known if there would be a Primary Election.

Friday, July 26, 2019 date was set for the General Registrar's Performance Review. The paperwork will be provided to State Board of Elections by August 1, 2019.

Tuesday, October 29, 2019 date was set for the Officers of Election, Informational Meeting.

Monday, November 4, 2019 date was set for the Chief Officers of Election to retrieve the election boxes and keys to the precincts for the Tuesday, November 5, 2019 election. Chairman Jones agreed to be present at the Registrar's Office from 9:00 a.m. to 12:00 noon. Wednesday, November 6, 2019 date was set for the canvass to begin at 9:00 a.m.

Those present reviewed the 2019 Election Deadline Calendar; Voting Systems Security Plan; BUDGET requests: Site Improvements to be included in the next fiscal year budget; and, Capital Project Request. Mr. Eugene Burton was sent an email advising the Voting Equipment Security Plan and Procedures had been reviewed and required no revisions.

The Early/No-Excuse Voting was discussed and agreed that a memo should be sent to Greensville County Administration advising of the future likelihood in the 2020 presidential election.

No further business, the meeting was adjourned.
